YARD DUTY AND SUPERVISION POLICY

PURPOSE

To ensure school staff understand their supervision and yard duty responsibilities.

SCOPE

This policy applies to all teaching and non-teaching staff at WSSC, including education support staff, casual relief teachers and visiting teachers.

POLICY

Appropriate supervision is an important strategy to monitor student behaviour and enables staff to identify and respond to possible risks at school as they arise. It also plays a vital role in helping schools to discharge their duty of care to students.

The Principal is responsible for ensuring that there is a well organised and responsive system of supervision and yard duty in place during school hours, before and after school, and on school excursions and camps and other school activities.

School staff are responsible for following reasonable and lawful instructions from the Principal, including instructions to provide supervision to students at specific dates, times and places. Supervision should be undertaken in a way that identifies and mitigates risks to child safety.

Before and after school

WSSC's grounds are supervised by school staff from 8.25am until 3.30pm. Outside of these hours, school staff will not be available to supervise students.

Before and after school the areas that are supervised are the main entrances and exits to the college and the bus stops. During break times areas are allocated to staff which cover the whole school area.

• Please note that students who attend the college before or after the supervision times are not supervised by yard duty staff.

Yard duty

All staff at WSSC are expected to assist with yard duty supervision and will be included in the weekly roster.

The Daily Organiser is responsible for preparing and communicating the yard duty roster on a regular basis.

Yard duty zones

Area A

- Area A is upstairs inside the main learning centre (CLC and ELC)
- Also monitor stairwell and lift if needed
- Although yard duty map indicates downstairs as well it is expected vast majority of time will be upstairs

Area B1 and B2

- Includes Oval, basketball court and area between GH and the stadium
- At end of break please go to supervise lockers and help get students to class
- On wet days area B2 supervises ELC and CLC inside with area A person. Use initiative to move in if weather changes

Area C

- Includes Canteen, lockers and courtyard
- At end of break please go to supervise lockers and help get students to class

Area C/D

- Includes ½ of grassed area, around Hair/Beauty and front of trade training building
- Check tables near bus stop
- At end of break please go to supervise lockers and help get students to class

Area E

- Includes front foyer of reception area, monitor students arriving/leaving via front doors
- Also monitor area at bottom of main stairwell

Bus Area - Woodland Street/Brockley Street


- Includes bus bays and bus shelters, monitor students arriving/leaving via buses
- Also monitor students are not accessing bus areas before bus come to complete stop
- Duty includes supervision of non WSSC students
- At end of morning duty, please go to supervise lockers and help get students to class


Wet Weather and Extreme Heat Process:

- Daily Organiser will email all staff re implementing Wet Weather or Extreme Heat YD process
- Area B2:
- the oval and soccer pitch are out of bounds. This applies even if it stops raining.
- $^{\bigcirc}$ $\,$ The basketball court is out of bounds on extreme heat days
- Staff member on duty in Area B2 will come inside to support Area A yard duty teacher

School staff must:

- wear a provided safety/hi-vis vest whilst on yard duty.
- Actively supervise students

Yard duty responsibilities

Staff who are rostered for yard duty must remain in the designated area until they are replaced by a relieving staff member.

During yard duty, supervising school staff must:

- methodically move around the designated zone ensuring active supervision of all students
- where safe to do so, approach any unknown visitor who is observed on school grounds without a clear legitimate purpose, and ensure they have a visitor pass and have signed in (excluding drop off and collection periods)
- be alert and vigilant
- intervene immediately if potentially dangerous or inappropriate behaviour is observed in the yard
- enforce behavioural standards and implement appropriate consequences for breaches of safety rules, in accordance with any relevant disciplinary measures set out in the school's Student Engagement policy
- ensure that students who require first aid assistance receive it as soon as practicable
- log any incidents or near misses as appropriate
- If being relieved of their yard duty shift by another staff member (for example, where the shift is 'split' into 2 consecutive time periods), the staff member must ensure that a brief but adequate verbal 'handover' is given to the relieving staff member in relation to any issues which may have arisen during the first shift.

If the supervising staff member is unable to conduct yard duty at the designated time, they should contact the Daily Organiser with as much notice as possible prior to the relevant yard duty shift to ensure that alternative arrangements are made.

If the supervising staff member needs to leave yard duty during the allocated time, they should contact the Daily Organiser but should not leave the designated area until the relieving staff member has arrived in the designated area.

Students will be encouraged to speak to the supervising yard duty staff member if they require assistance during recess or lunchtime.

COMMUNICATION

This policy will be communicated to our school community by:

- Being available on the school website and portal.
- Included in staff induction processes
- Discussed at staff briefings or meetings, as required
- Included in our staff handbook
- Made available in hard copy from school administration upon request

Information for parents and students on supervision before and after school is available on our school website and parent reminders are sent at the beginning of each term in our school newsletter.
